

## Vital Needs of Ashland Pregnancy Care Center in Ashland County

The Ashland Pregnancy Care Center began as Ashland Crisis Pregnancy Center in 1981, utilizing a single room in Andrews Hall at Ashland College. The purpose of this organization was to minister to and help women and men make wise decisions when faced with an unplanned pregnancy. This group became passionate about the sanctity of all human life. The goal was that APCC would be there to equip women to choose life for their pre-child by providing pregnancy testing and mentoring, as well as physician, counseling, and adoption referrals at no cost to clients. These core values and community benefit have remained the strength of APCC for over 35 years.

Since 1990, the center has enjoyed significant growth in client services. Because of caring donors, funding for new medical facilities became a reality in 2007 including the opportunity to provide limited OB ultrasound services.

Since that single room office in Andrews Hall at Ashland College in 1981, the Ashland Pregnancy Care Center has provided their Christian support and compassion to over 4,200 individuals and families in Ashland County and surrounding areas; assisted 35,000 visits to the center for services; administered over 6,000 pregnancy tests; performed over 400 ultrasounds; and saved over 1,700 babies from abortion! Our goal is to equip them to live and thrive abundantly in our community... we are succeeding!

### **Mission Statement:**

The Ashland Pregnancy Care Center is a Christ-centered ministry offering compassion, hope, and help to women and men facing critical pregnancy decisions by *establishing* trusted relationships, *equipping* with education and resources, and *empowering* families to live life according to God's plan.

## Four Important Steps to Establishing an Endowment with Ashland Pregnancy Care Center and Ashland County Community Foundation.

4. The principal (amount given) will always remain restricted and only the income distribution will be used to benefit the Ashland Pregnancy Care Center.

In 1995, an Ashland County strategic plan identified a priority need – establish a community foundation. Under the leadership of Founding President, Dr. Lucille Ford, and a committed board of volunteer trustees, the Ashland County Community Foundation (ACCF) became a reality. With limited resources to start, this group of dedicated leaders was counting on that which they knew to be true – the caring spirit and generosity of Ashland County residents to support causes in which they believed.

Now, 20-plus years later, ACCF has accumulated assets of over \$40 million. More importantly, over \$11 million has been reinvested in Ashland County through the award of scholarships, grants and individual fund distributions.

With the trust of over 7,000 donors, ACCF is faithfully executing its mission “...to advance philanthropy and improve the quality of life in Ashland County.”

The Ashland Pregnancy Care Center and the Foundation have formed an endowment “Partnership of Caring” initiative. ACCF will provide expertise to the organization and its prospective donors on establishing a designated, permanently-endowed funds at the Foundation. The earnings from these endowments will provide an ongoing source of revenue for the Ashland Pregnancy Care Center.

Each of these endowments can provide an instrument for the organization to receive planned gifts of various types, including cash, appreciated stock or real estate. Over 25 non-profit agencies, throughout Ashland County, have established an endowment partner relationship with ACCF.

You can create your endowment now, establish it in your will, or create it through a trust that benefits your family as well as the Ashland Pregnancy Care Center. ### • How large of a gift is necessary to create an endowment?

To establish an endowment that is named for the donor, or in honor of a loved one, or to celebrate a specific event in your life, the contribution must be at least \$10,000. An initial gift of \$2,000 is necessary with the balance paid within five years. The donor has the option of whether to have the creation of the endowment made public.
